MINUTES OF THE 14TH ANNUAL GENERAL MEETING OF THE ALL INDIA PUBLIC SECTOR SPORTS CONTROL BOARD HELD ON 24TH SEPTEMBER, 2023 AT NEW DELHI

Thereafter the items on the agenda were taken up for discussion:

ITEM No.1

Filling-up vacant posts of Board for the term upto 31st March, 2025

General Secretary informed that after superannuation of Board Members including Shri Parmod Aggarwal, IAS from the services of Coal India Ltd. the post of Key functionaries are vacant namely President / Vice President & other executive members. The house unanimously re-nominated the executive Members & National Game Co-ordinators from Member organizations for the present term up to 31st March, 2025

PRESIDENT As per past practice, the incumbent CMD/Head of the Organization of the respective organization from where the President superannuated complete the remaining term of the Board, Accordingly the house unanimously desired that Shri P.M. Prasad, CMD, Coal India may be offered the position of President (AIPSSCB). It was decided that the respective organizations of the National Game Co-coordinators will bear their TA/DA while on sports assignment with the Board.

In respect of Consultant (AIPSSCB) TA/DA expenses will continue be borne by the Board as he is not an employee of any organization to avail such facilities, however the host units may take care of accommodation/local transportation facility for the Consultant (AIPSSCB) during his stay for the concerned AIPS Tournament/meeting.

The House delegated its powers to the President for filling-up the remaining vacant posts in Executive Board on the recommendations of member organizations and in consultation with Executive Board.



ITEM No.2.

Extension of Term of Administrative Staff till 31st March, 2025

2.1 The Board unanimously ratified the decision taken with the approval of Executive Vice President (AIPSSCB) to extend the tenure of the Consultant Shri Ramesh Sachdeva till 31st March, 2025 as per existing emoluments.

2.2 Tenure of Auditor M/s Chawla Ranjinder & Co

On a suggestion by the Treasurer, it was unanimously decided to continue with the present Auditor M/s Chawla Rajinder & Co. till 31st March, 2025 taking into consideration his vast experience in the field. However it was further decided the AIPSSCB may confirm whether there is restriction in number of years an auditor can be appointed in any association which is registered under Society Act, in case a restriction does exist, a suitable alternative arrangements may be made.

2.3 On the request of Treasurer (AIPSSCB) remuneration being paid to Chartered Accountant and Accountant who maintain the accounts books is being enhanced to Rs.30,000/- per annum and Rs.12,000/- per annum respectively. It was informed that the emoluments have not been enhanced since 2017.



2.4 The tenure of M/s Aeron Enterprises (web-side designing/maintenance) has also been extended up to 31st March, 2025 as per existing emoluments keeping in view his requirement to give publicity / visibility of the Board activities.

He further requested, in case they are not in a position to conduct the event because of some unavoidable reasons the same may be intimated to the Board well in advance so that alternate arrangements could be made.

It should also be ensured that at least 6 member organizations participate in an event.

ITEM No.7

ANY OTHER POINTS WITH THE PERMISSIN OF CHAIR

- 7.1 The House approved the proposal to take necessary action in respect of Units of Rs.1.00 lakh face value invested in (UTI) Union Trust of India.

- 7.3 The House agreed to the proposal of the Treasurer (AIPSSCB) that surplus amount of the Board which is kept in fixed deposits in two different banks may be transferred in one of the nationalized banks for easy operations.
- 7.4 "IT WAS RESOLVED & DECIDED THAT "Shri Vinay Ranjan, Executive Vice President (AIPSSCB)/Director (P & IR) CIL, Shri Gian Batra, General Secretary (AIPSSCB) / General Manager (HR) —AAI and Sh. O.P. Dani, Treasurer (AIPSSCB) / Chief General Manager (FCI) are nominated as authorized signatories of the AIPSSCB. Any of the two executives i.e. Executive Vice President (AIPSSCB), General Secretary (AIPSSCB) and Treasurer (AIPSSCB) are authorized to operate the Bank Accounts of the AII India Public Sector Sports Control Board."



- 7.5 Since Air India is one of the founder members of the Board, the house unanimously decided that their membership may be continued to provide a national level platform to their sportspersons/teams. The management of Air India has been taken over has taken over by M/s TATA Industries.
- 7.6 General Secretary informed the House that Income Tax Department had requested for grant membership of the Board, which was accepted subject to the condition that they agree to pay the annual requisite membership fee.
- 7.7 Efforts may be taken at the level of Executive Vice President / Vice Presidents to approach PSUs/ Autonomous bodies/Government institutions having separate sports control boards to become members.
- 7.8 Keeping in view chances of injuries are high in the team games like Football, Hockey & Cricket and on the request of Member Organizations, it was unanimously decided to Increase the number of players participating in AIPS Tournaments in team games only like Hockey, Cricket & Football from 18 to 20 (maximum) which includes support staff viz. Manager, Coach, Mentor
- 7.9 Due to escalation in prices it was decided to enhance the Trophies & medals allowance being reimbursed to host member PSUs for conducting AIPS Tournaments on behalf of AIPSSCB from Rs.30,000/- to Rs.50,000/- (viz. the maximum limit)

The Vice President (AIPSSCB) Shri Anuj Kumar, Director (Fin.) CWC at the outset thanked the House for giving him the opportunity of to Chair the meeting.
