Shri Gian Batra, General Secretary (AIPSSCB) / General Manager (HR) - AAI, welcomed Dr. Vinay Ranjan, President (AIPSSCB) / Director (P & IR) Coal India Ltd., Shri Suneel Dutt, Executive Director & Vice President AAI Sports Promotion Board, Shri O.P. Dani, Treasurer (AIPSSCB) / Chief General Manager (FCI), and other representatives from member organizations

In his welcome address Shri Gian Batra expressed his happiness to attend the AGM of AIPSCB and meet sportspersons, sports administrators, key executive of member organizations and share with them thoughts for improvement of sports in the country.

He was sure delegates present would as always give their suggestions for the overall benefit of the functions of the All India Public Sector Sports Control Board.

He thanked all the Member Organizations who organized sporting events in the last year. He informed that they had received words of praise from the sporting fraternity in the various cities where events were conducted about the quality of tournament which were as good as any National Sporting event of the country.



General Secretary congratulated Reserve Bank of India for entering their 90th year of establishment on 1st April, 2024. To commemorate the occasion, the RBI had hosted All India Public Sector Football Tournament at Kolkata during August, 2024 & All India Public Sector Badminton Tournament at Bengaluru during January, 2025. The podium finishing sportspersons participating in these events were awarded a total prize money of Rs.20 lakhs in each event

He further informed the House that Food Corporation of India hosted the All India Public Sector T-20 Cricket Tournament at Abhimanyu Cricket Academy Grounds (one the finest cricket ground in the country surrounded by valleys) at Dehradun (UK) during Feb./March 2025. All the 23 matches were live screened in YouTube channel and the final match was played under flood lights. For live screening of all the matches credit goes to M/s Sports Oodles Pvt. Ltd. who have been associated with the Board to promote the sports activities.

Coal India Ltd. under the dynamic leadership of our President Dr. Vinay Ranjan hosted Hockey tournament at Kolkata in a totally professional manner. Olympian Sri P.R.Sreejesh (Padam Bhushan Awardee) felicitated during closing ceremony of the tournament.


FORMATION OF THE EXECUTIVE BOARD FOR THE




FINALIZATION OF SPORTS CALENDAR FOR THE YEAR 2025-26



ITEM No.6.**ANY OTHER POINT WITH THE PERMISSION OF CHAIR**

6.1 Smt. S. Gayathri, Secretary (HRD/Training), Life Insurance Corporation of India informed the House that LIC Volleyball Team could not participate in the AIPS Volleyball Tournament organised by HPCL at Gwalior during November, 2025 as the dates of the said tournament clashed with their Departmental volleyball event. In spite of advance request to the Board for change of dates of the PSU event, the request was not entertained. She requested the Board that in future efforts should be made to ensure clashing of the same event of member organization/Board does not take place. The President assured full co-operation in the regard.

6.2 On the basis of the recommendation of the Sub Committee constituted regarding optimum utilization of the funds of the Board, it was decided in the last AGM held on 28th Sept., 2024 to field the composite team of the Board in the major/reputed tournament to give adequate exposure to our sportspersons. General Secretary (AIPSSCB) Shri Gian Batra informed the House that Oman Hockey Association (affiliated to International Hockey Federation & Asian Hockey Federation) desired to play a three match bilateral hockey series against AIPSSCB Board President XI man. The Oman Hockey Association agreed to bear all expenses of the Board President XI team (including support staff) during their visit to Oman which includes Boarding & lodging, local transport etc. The AIPSSCB has to bear airfare expenditure (both ways) for its participants. Similarly, the Board has to bear the entire expenses of the



OHA contingent visiting India to play a three match series, however airfare will be borne by Oman Hockey Association.

After detailed discussion the House unanimously agreed to the proposal in principle for playing a three matches hockey series between Board President XI and National Team of Oman fielded by Oman Hockey Federation at Oman & India on reciprocal basis. However, the General Secretary (AIPSSCB) was advised to nominate a three-member committee to examine the proposal in detail and thereafter place it to the Executive Board for approval.

On the completion of the agenda items Shri Gian Batra, General Secretary (AIPSSCB) escorted the new President Shri Vipin Kumar, IAS, Chairman, Airports Authority of India to the venue of the meeting. All the members present in the Annual General Meeting wholeheartedly welcomed the new President Shri Vipin Kumar, IAS.

Shri Vipin Kumar, IAS, Chairman – AAI thanked the House for placing confidence on him to lead the Board as its President. He assured all present that he will leave no stone unturned for the promotion of the activities of the Board.




