MINUTES OF THE 11TH ANNUAL GENERAL MEETING OF AIPSSPB HELD AT PANDIT DEENDAYAL UPADHYAYA URJA BHAWAN, (PDUUB) NEW DELHI ON 6TH JULY, 2017

The 11th AGM (2015-16) of All India Public Sector Sports Promotion Board (AIPSSPB) was hosted by ONGC at PDUUB, Vasant Kunj, New Delhi on 06.07.2017 which was presided over by Sh. D.K. Sarraf, CMD, ONGC –President AIPSSPB.

List of participants is appended at Annexure – A.

At the outset Shri V.K. Mahendru, General Secretary /GGM (ONGC) welcomed Shri D.K. Sarraf, President – AIPSSPB, CMD – ONGC, the newly nominated Vice Presidents (AIPSSPB) Shri Anuj Aggarwal, Member (HR) - AAI, Shri R.K. Chaturvedi, Executive Director – FCI and the other office bearers of the board & representatives of Member Organizations

In his opening address President-AIPSSPB hoped that the board activities would supplement country's effort to help sportspersons reach higher level of performance and showcase National pride. Thereafter the item-wise agenda circulated by AIPSSPB was taken up for discussion and the following decisions were taken:-

ITEM No.1

i) RATIFICATION OF THE DECISIONS TAKEN WITH THE CONSENT/APPROVAL OF PRESIDENT – AIPSSPB

The under mentioned decisions taken with the consent/approval of President – AIPSSPB were ratified unanimously by the House.

- a) Nomination of Shri V.K. Mahendru, GGM (ONGC) Delhi as General Secretary of the Board.
- b) Sports Calendar for the year 2016-17.
- c) Extension of the tenure of Shri Ramesh Sachdeva as Consultant for a period of one year i.e. upto 31st March, 2017.
- d) Filling up of vacant position of Executive Board.
- e) Nomination of National Games Co-ordinators: i)Badminton Ms. Trupti Murgunde (IOCL), ii) Cricket Sh. Amarjeet Kaypee (FCI), iii) Carrom Sh. V.D. Narain (LIC), iv) Football sh. Victor Amalraj (FCI), v) Hockey Sh. Dhanraj Pillai (AI),vi) Golf Sh. S.D. Prasad (CIL/MCL) vii) Table Tennis Ms. Vishakha Vijay (ONGC) and viii)Chess- Ms Harika Dronavalli(IOCL).

Mr. D.V. Prasad Chief Manager (Sports) of IOCL explained to the house that Ms Harika being an active player has to travel a lot within and outside the country which makes it extremely difficult for her to contribute as NGC and thus suggested for her replacement. President asked Gen Secretary to look for an alternate name and put up for approval.

Members expressed their gratitude to the President (AIPSSPB) for nominating an experienced, dedicated & dynamic individual as General Secretary & expressed optimism that it will provide the required impetus to the board's functioning.

In one voice, the house consented for ratification of all the above decisions. The house also approved the next four year tenure of the board so formed (2017-2021) with the only modification that in place of Sh. A.N. Rai of BSNL, Mr. Kalbir Singh DM (Sports) was considered in view of former's superannuation.

ITEM No. 2

CONFIRMATION OF THE MINUTES OF THE LAST ANNUAL GENERAL MEETING

The minutes of the last AGM held at Kolkata on 27^{th} June, 2015 were confirmed by the House.

ITEM No.3

AUDITED ACCOUNTS FOR THE YEAR 2015-16

The audited accounts for the year 2015-16 were placed for approval of the House. Shri Harish Makhija, Treasurer/Registrar EPF (AT) gave a brief report for the year 2015-16 as per details below:

In reply to a query of the President, it emerged that the Board is not filing its Income Tax return, though it has obtained PAN from the Income Tax Department and some tax is also being deducted at source from the interest on fixed deposits. The President advised that necessary urgent action be taken for getting income tax exemption under relevant section of the Income Tax Act, 1961 and filing of returns.

Thereafter, the audited accounts for the year 2015-16 were approved by the House.

It was observed that some member PSUs are not paying the annual subscription regularly. It was therefore decided that such organizations may be approached/persuaded at the level of President & Vice Presidents - AIPSSPB to be regular in their payment

It was also approved that since Rajinder Singh Chawla, CA is associated with the Board for a long time as Auditor, the board should look for fresh auditors w.e.f. 1st April, 2018. Till then we may continue with the existing auditor. Necessary procedure may be followed for such appointment.

ITEM No. 4

AFFILIATION WITH SPORTS FEDERATIONS

After discussion, It was unanimously decided that AIPSSPB should approach various sports federations / associations for seeking affiliation so that a composite team of the board consisting of players from organizations who are not affiliated with these Federations can be fielded in National Championships, which will give the desired exposure to players of these organizations at the National level besides providing visibility to the board. It was informed that the annual financial implication for the same would be only nominal.

ITEM No. 5

TALENT SEARCH SCHEME

After discussions it was decided in principle to introduce the Talent Search Scheme. Accordingly a Committee under the chairmanship of Vice President – AIPSSPB Shri Anuj Aggarwal, Member (HR) AAI was constituted. The other members of this committee will be Sh. R.K. Chaturvedi, V.P. (AIPSSPB) & ED|(FCI), Shri G.L. Verma (AAI) – Executive Board Member, Ms. Anuradha Biswal (NALCO), Ms. Roopam Sharma, Jt. Secy. (AIPSSPB) & GM (CA), Ms. Vishakha Vijay, ONGC-NGC and Shri V.K. Mahendru – General Secretary (AIPSSPB). The Committee will finalize the modalities for the selection of sportspersons under this scheme within a period of 45 days and put up to President for approval.

ITEM No. 6

ENHANCEMENT OF ANNUAL SUBSCRIPTION

There was a detailed discussion on this subject and some organizations expressed their inability to pay an enhanced subscription to the tune of 100%. However considering the cost escalations and also the proposed introduction of various programmes such as scholarship scheme for the upcoming youngsters, monetary incentive for the National & International performers and supporting sports promotional activities in rural & urban areas to help make sports as way of life, a 50% hike in the annual subscription was agreed to. The revised payable subscription would be as under w.e.f. the year 2017-18:

EXTENSION OF TENURE OF CONSULTANT

The house agreed that in the absence of a dedicated work force for the Board & Shri Sachdeva being well versed with the functioning of Board, his services are extended for one more year i.e. from 1st April 2017 to 31st March 2018.

ITEM NO.8

ENHACNEMNT OF MONTHLY MAINTENACE CHAREGES BEING PAID TO WEB-SITE DESIGNER OF THE BOARD

It was decided to enhance the monthly maintenance charges payable to web- site designer of the Board M/s Aeron Enterprises from Rs. 8,000/- per month to Rs. 10,000/- w.e.f. 1st April, 2017 in view of the general escalation and the quantum of work involved in maintenance of the web site,

PATRON OF THE BOARD

It was unanimously decided to request Secretary DPE to take over as Patron of the Board as the Board is basically for promotional activities of sports amongst Public Sector Undertakings. Further, it will greatly help in expansion of the Board's activities.

11.1 SOUVENIR

11.2 EXHIBITION MATCHES

It was decided to organize a friendly cricket match during the year with participation of senior management of member companies for a better camaraderie and also for useful suggestions of the top executives for better sports management.

11.3. TENURE OF NATIONAL GAME CO-ORDINATORS

- i) It was decided that the tenure of the National Game Co-ordinators (NGCs) of AIPSSPB should be to two years.
- ii) Due to financial constraints it was decided that the travel, boarding & lodging expenses of NGCs will be borne by their respective organisations. treating them on official tour while performing the duties of the AIPSSPB on a written request by the General Secretary (AIPSSPB) to the concerned organisation as is being done for their representatives who attend board meetings as notified from time to time.

PARTICIPATION CERTIFICATE 11.4

The non- issuance of participation / merit certificate in respect of Public Sector Tournaments by the Host Units was raised by some members. It was principally agreed to issue participation/merit certificate in respect of AIPSSPB tournaments under the signature of General Secretary (AIPSSPB) and one representative authorized by the Host unit. However list of certificates issued in respect of every tournament should be submitted to the Board for record. The General Secretary was assigned the task of designing the participation/merit certificate to be issued.

Further it was decided that Rules & Regulations in respect of such tournaments should be sent to all the member organizations to ensure uniformity & clarity in conduct of the tournament.

Shri D.K. Sarraf, CMD, ONGC in his Presidential address expressed his satisfaction for the successful conduct of games during the preceding years and wished all participants the very best for a happy and memorable year 2017-18. He exhorted upon all to conduct the tournaments within the financial year and not spill over to the next financial year which could result in budgetary difficulties for the participating teams. He thanked the members for their vibrant participation in the meeting.

The meeting ended with a vote of thanks to the President, & other participants by General Secretary AIPSSPB. The General Secretary requested the President & other dignitaries to distribute the Awards for Excellence in sports amongst PSUs for the year 2015-16 which were as under:
