MINUTES OF THE 12TH ANNUAL GENERAL MEETING OF AIPSSPB HELD AT DEENDAYAL URJA BHAWAN, (DUB) NEW DELHI ON 19TH NOVEMBER, 2018

The 12th Annual General Body Meeting of the All India Public Sector Sports Promotion Board was hosted by Oil & Natural Gas Corporation Ltd (ONGC) on 19th November, 2018 at New Delhi and was chaired by Shri Shashi Shanker, CMD-ONGC - President All India Public Sector Sports Promotion Board. List of participants is appended at **Annexure A.**

To begin with, Shri V.K. Mahendru, General Secretary (AIPSSPB) / GGM (ONGC) welcomed the President Shri Shashi Shanker, Shri Subhash Kumar, Director (Fin.) ONGC, Vice President Shri Anuj Aggarwal, Member (HR) AAI and the other attendees.

In his opening address, President expressed his desire to make the board more participative so that a larger segment is at work to promote sports in the country under the banner of AIPSSPB. He emphasized on need for focus on rural areas where talent is aplenty but resources are scarce. He exhorted upon all to identify and help the talented lot who are unable to make a mark due to paucity of required infrastructure, playing equipments, kits & liveries etc. President then asked General Secretary to take up the agenda items preceded by Action Taken Report in respect of last AGM. The General Secretary thereafter gave a point wise brief on the ATR and after due deliberations the under mentioned decisions emerged:-

i) In respect of nomination of National Games Coordinators (NGCs) it was decided that the existing vacant positions may be filled up after seeking recommendations from the Member Organizations.

ii) As the present Auditor has been working with the Board for a considerable period of time. It was decided to identify a new auditor from 1st April, 2019. A three member committee comprising of General Secretary (AIPSSPB), Treasurer (AIPSSPB), and Sh. O.P. Dani, Secretary FCI Sports Promotion Board was nominated to submit recommendation for approval.

Even Petroleum Sports Promotion Board is affiliated with some of the federations/associations and many petroleum PSUs are members of AIPSSPB also. MINUTES OF THE 1st MEETING OF SUB-COMMITTEE OF AIPSSPB HELD IN THE CHAMBER OF MEMBER (HR) AIRPORTS AUTHORITY OF INDIA AT RAJIV GANDHI BHAWAN, NEW DELHI ON 24TH AUGUST, 2017

In keeping with the decision taken in the 11th AGM of AIPSSPB regarding introduction of Talent Search Scheme, the Sub Committee constituted thereof held its meeting which was hosted by Airports Authority of India at Rajiv Gandhi Bhawan, New Delhi on 24th August, 2017. The meeting was presided over by the Chairman of the Sub Committee, Vice President (AIPSSPB) & Member HR AAI Shri Anuj Aggarwal. The other members present were:-

Ms. Roopam Sharma, Joint Secretary (AIPSSPB) / GM (Air India) who was also the member of the Sub Committee could not attend the meeting due to her prior commitment.

At the outset Shri V.K. Mahendru, General Secretary welcomed the Chairman of the Sub Committee Shri Anuj Aggarwal, Vice President – AIPSSPB, Member (HR) AAI, Shri R.K. Chaturvedi, Vice President – AIPSSPB /Executive Director – FCI and the other Committee Members.



Point wise Agenda of the meeting was then deliberated as under :-

1. TALENT SEARCH SCHEME

The Committee Chairman expressed the view that explicit guidelines should be framed

regarding this scheme in respect of sports to be assisted, type & quantum of assistance,

eligibility criteria etc. He also said that once all these formalities are completed, the

applications should be called through advertisement in the AIPSSPB web-site also

besides the methodology as suggested by NGCs. Posting on Web site will give wider

access to people.

After detailed discussions the Committee was unanimously of the view that at least

three outstanding sportspersons in each game may be considered for sponsorship

under this scheme. The games to be considered are:-

1) Table Tennis

2) Badminton

Athletics (Selective events)

4) Archery

5) Wrestling

Boxing

The members were in agreement with the view of the Chairman that at first stage we

must finalize the sponsoring PSUs before identifying the beneficiaries of this scheme.

To do so, it was decided to expedite the process of anointing Secretary DPE as patron

of the board so that a high level meeting involving CMDs /Directors/other Senior officers

of the member PSUs is held to seek their firm commitment to support the said scheme

of talent search & their grooming thereof. The very purpose of this scheme is to identify

the upcoming/potential talent & support them for a certain period to make their world

beaters.

The matter regarding granting of sports scholarship to be given by AIPSSPB was discussed and after due deliberations it was decided that the several member organizations are having the said scheme it is perhaps not necessary for AIPSSPB to venture into it.

3. CASH AWARD

To encourage the outstanding sportspersons belonging to member PSUs, it was decided that Cash Incentive could be given for excellence in National/International tournaments. Following is proposed for various events:-

MINUTES OF THE 1ST MEETING OF NATIONAL GAME CO-ORDINATORS HELD AT NEW DELHI ON 30TH AUGUST, 2017

A meeting of National Game Co-ordinators of AIPSSPB was held on 30th Aug., 2017 presided over by General Secretary (AIPSSPB) Shri V.K. Mahendru. The National Game Co-ordinators in the game of Carrom, Table Tennis & Badminton namely Shri V.D. Narayan (LIC), Ms. Vishakha Vijay (ONGC) and Ms. Trupti Murgunde (IOCL) respectively attended the meeting.

After detailed discussions, the following were suggested for the consideration of the Sub-Committee constituted for Talent Search Scheme:-

OBJECTIVE

The scheme aims at providing a package of assistance / sponsorship to the promising sportspersons in various sports disciplines, based on their talent assessment by a team. Presently, following game disciplines have been proposed for consideration of providing such assistance. These games have been considered keeping in view the proposed of medal winning prospects.

Eligibility Criteria

It is proposed that the sponsorship under the Scheme can be extended to two categories of sportsperson namely:-

- A) Players with proven track record but require further having of skill
- B) Upcoming youngsters with immense promise & talent

For category "A" players a screening committee comprising of National coach of the sports respective NGC & Gen Secretary, AIPSSPB will examine the profile of the player & seek Federation / Association's view on the kind of assistance that the individual needs & for how much time which will give an indication of the financial implications. The proposed as careful scrutiny will be put up to EC of AIPSSPB for approval.

For category B Players the respective NGC will identify the upcoming youngsters who have potential to perform at the highest level & recommend his / her case for long time

sponsorship programme. The proposal will be supported with documentary evidence of at least last two years performance of the players alongwith type of skill enhancement programme recommended, its periodicity & cost implication. It will then be examined by the same screening committee as in case of category Ä"& put up to EC for approval.

Other Guidelines:

- i Age of the players under consideration of this scheme should not be more than 25 yrs on the date of application.
- ii Performance of the beneficiaries of the scheme would be monitored by the Screening Committee every six months & decision for his/her continuation/discontinuation would be taken accordingly.
- iii Gen. Secretary AIPSSPB will recommend the periodical payment of the sports person so chosen under the scheme to the sponsoring PSU.
- iv In order to assess/identity the prospective candidates for consideration under the scheme the NGCs will be permitted undertake a maximum of 3 tours in a financial calendar year to various places where important events / camps are organized to have a look at the performance of the players. All their expensed to this effect will be borne by their respective employer PSUs. Based on the request of the NGC the requisite letter will be written by Gen. Secretary, AIPSSPB to the concerned PSU for facilitating such tours.
