ITEM NO. 5

To give a boost to the activities of the Board, the Executive Vice President desired that efforts should be made to enroll more organization as Members of the Board. A target of obtaining 25 new memberships should be fixed. In the connection he suggested that the personal indulgence of the President can be utilized for contacting the Head of the various organizations. Even financially not so strong companies could be considered concessional annual subscription.

The Executive Vice President also suggested that a Seminar may be conducted during February 2023 at New Delhi inviting all the member organizations/ non-member organization involved with promotion sports/renowned sportspersons of the country for discussions regarding promotion of sports in the country in the grass root level.

To make the Board more vibrant he suggested the social media may also be utilized for intimating the activities of the Board. In this regard the General Secretary informed the House that the Board has already signed a MOU with M/s Sports Oodles for live screening of various tournaments conducted by the Board/its member organizations, which has brought mileage to the Board.
